Year 6 - Surf Residential Monday 14th - Tuesday 15th July 2025

We are very excited to announce the end of year residential that we are organising for our Year 6 pupils.

We have arranged for the Year 6 children to go on a surfing residential in Widemouth Bay from 14th to the 15th July 2025. We have taken the Year 6s for the last couple of years and it has always been a huge success.

We are planning an overnight visit to OA Surf Club at Widemouth Bay, Bude. The children will experience staying in a cliff top location with spectacular views over the Atlantic with private access to beautiful Wanson beach. They will take part in two days of activities, including surfing, body boarding and a variety of outdoor team building games. Surf and body boarding sessions are run by instructors with 25 years of experience and are tailored to this age group, although ideally children should be able to swim a minimum of 15 metres. This trip will be staffed by Miss McLean and the senior leadership team from the school.

This overnight visit will provide a fantastic opportunity for the children to learn exciting new skills, develop team building, encourage personal development and celebrate their time at Primary School before moving up to secondary school.

All instruction and equipment is provided, and we will send out a full kit list nearer the time.

We will provide transport to the venue from Winkleigh Primary School but do ask parents to arrange collection of their child from Widemouth Bay at 12.30pm on Tuesday 15th July 2025.

In view of the ever-increasing cost of coach transport, it is unfortunately not financially viable for us to arrange transport from Kings Nympton. To keep the cost down, we would therefore like to ask parents to drop their child to Winkleigh Primary School on the day. We thank parents very much for their support with this.

We appreciate that for many of you, you have only just finished paying for the London Residential so we have looked into how we can subsidise this trip to make it as affordable to parents as possible. We want to give the children as many valuable opportunities and character-building experiences before they finish their time in primary school.

Using a generous donation from school fundraising and PE Premium funding, we are able to provide this residential for £85.00 per child. This trip would have cost £125.00 without these subsidies.

We hope that all our year 6s take up this opportunity. Payments towards this trip is non-refundable. Should you or your child decide that they do not want to attend this residential, they will attend school as normal and work in another class.

A payment request has been set up on the Gateway. To help spread the cost, we have set it up so that you can pay in two instalments, following payment of a non-refundable deposit. You may pay in full if you prefer.

Non-refundable deposit: £15.00 due by 16th May 2025

Payment 1: £35.00 due by 31^{st} May 2025 Payment 2: £35.00 due by 30^{th} June 2025

Total: £85.00

Full payment must be received by 30th June 2025. If full payment is not received by this date, your child will be unable to attend the residential.
