Please use this form to indicate which sessions you would like to book for the above term.

The rate charged over and above funding hours (if applicable) for 9 months up to 2 year olds is £10.30 per hour, 2 year olds is £6.50 per hour, 3 and 4 year olds is £5.40 per hour.

Early Years Funding

For eligible working parents the term following your child's 9 month 'birthday' your child will become eligible for Early Years Funding, the first 30 hours attended per week, up to a maximum of 1140 per academic year, is free of charge to you.

Attendance over 30 hrs per week or over the total allowance of 1140 hours per academic year will be charged at the 9 months - 2 year old hourly rate.

We are a **registered 2 year old funding provider** and your child is welcome to start in our Nursery as soon as they turn two. Some 2 year olds are eligible for funded childcare if parents are in receipt of certain benefits. You can check your eligibility on the Citizen Portal https://oneonline.devon.gov.uk/CCSCitizenPortal_LIVE/en

The term following your child's third birthday your child will automatically become eligible for Early Years Funding, the first 15 hours attended per week, up to a maximum of 570 per academic year, is free of charge to you.

Anything over 15 hrs per week or over the total allowance of 570 hours per academic year will be charged at the 3-4 year old hourly rate.

You may be eligible for 3-4 year old 30 hrs funding. To check your eligibility visit <https://beststartinlife.gov.uk/>. If you are eligible you must provide us with your eligibility code and National Insurance Number for verification before you can use the extended funding.

Early Years Funding normally begins the term after the funding application date as below;

Please be aware that when you sign the Early Years Entitlement Funding form during Headcount Week (you will be advised when this is), you are agreeing that your child will attend the sessions as detailed, and Winkleigh Nursery will make the appropriate funding claim accordingly. In making this claim the Nursery becomes financially liable in the event of a child's unauthorised absence; therefore, The Woodland Federation School Governors reserve the right to pursue these costs if your child is absent. You are also agreeing to pay for additional sessions booked over and above funded hours at the rates shown. If your child is absent due to illness, holiday or appointment you will still be charged if your booking exceeds your funding allowance. If your child attends another provider in addition to Winkleigh Nursery please complete the box on the final page of this form to ensure that there is not an overclaim of funding.
